In respect of maintenance of academic and financial discipline the college will strictly **f**ollow norms of NCTE (in strict observance of the latest notification)/State Government Orders issued from time to time and relevant conditions/rules of the Affiliating University in this regard especially with respect to the minimum number of teaching days in an academic session as stipulated by the Affiliating University/NCTE.
- 7. Expert(s), duly authorized by the University may make 'surprise visit' to the college for rap id, on-spot assessment of the quality of functioning. If any short-fall / discrepancy is identified by the Inspection Team, affiliation of the programme may be withdrawn.
- 8. The college authority shall abide by the Acts, Statutes, Regulations etc. of this University as are in force or as may be amended from time to time.
- 9. Admission of students will be as per norms stipulated by the University.
- 10. Staying in the college hostel, if any, is not mandatory for the students.
- 11. The Governing Body of the College is to be constituted as per provisions of the State Govt. / Affiliating University.
- 12. The following school subjects are approved as Pedagogy subjects for curriculum transaction at your college along with other foundation courses and optional courses, if any :

Bengali, English, Geography, History, Life Science, Mathematics, Political Science, Sanskrit

- 13. This affiliation to be renewed per year.
- 14. Fees structure for B.Ed. programme will be fixed up by the NCTE Norms & Higher Education Department, Govt. of West Bengal.
